Our Mission: OSR supports the Port of Seattle's job creation and economic development efforts in the communities we serve, and our programs help ensure that port activities are conducted within a framework of equity, inclusion and equal access to economic opportunity.

Century Agenda: OSR is helping the Port achieve its vision of creating 100,000 new jobs by promoting small business growth and supporting workforce development programs.



2012 Highlights

OSR and the programs we support:

- Served over 9,000 community members and small businesses
- Created more than \$68 million in value for the community an ROI of more than 32:1
 - Small Business (over \$44 million)
 - Workforce Development (over \$24 million)
 - Community Giving (over \$100 thousand)




Small Business Program

- 35% of all eligible expenditures went to small businesses
 - Up from 28% last year
- Over \$44.4 million went to 464 small businesses








Workforce: Apprenticeship

- 15% of eligible labor hours by apprentices
- Over \$1 million in wages to 127 apprentices



Workforce: Apprenticeship

- 13% of apprentice hours were done by apprentices of color
- 3% of apprentice hours were by female apprentices
- 171 apprentices graduated to Journey status who had worked on Port projects at some point



Workforce: Century Agenda - Maritime

- Helping to build and support a maritime workforce development consortium
- Progress to be reported as a part of Century Agenda updates

Workforce: Internships

- 51 paid internships and fellowships
- Veterans Fellows, National Urban Fellows, HRD w/sponsoring departments, C-WEST, SYEP




Workforce: Port Jobs

Served over 7,600 community members in 2012

- Airport Jobs helped 1,088 people get jobs
- Over \$19
 million in
 new income
 into those
 households

2012 Job Placements by Employer Type



Workforce: Port Jobs

- Provided training to 234 employees at the airport through Airport University
 - 108 of those employees earned college credits
- Through ANEW's Apprenticeship Opportunity Project, provided pre-apprenticeship and apprenticeship support to 212 community members
 - 125 became registered apprentices and 7 others got new trades-related jobs
 - Over \$4 million in new wages to those households



Community Giving Campaign

- Generated over \$112,000 in donations through payroll deductions for 168 community nonprofits
 - 161 Port staff participated
- Provided volunteer opportunities to staff throughout the year
