Sustainable Airport Master Plan

First Quarter 2016 Outreach and Engagement Report

Summary of Activity

Master Plan outreach in 1Q2016 included briefings to the SeaTac City Council, SeaTac's Hotel/Motel Advisory Committee; and a presentation to the Highline Forum.

Work continued with Port-hosted business roundtables in Des Moines, Burien and Normandy Park.

The Port held the second round of community open houses in Seattle, Bellevue and SeaTac; and distributed *AirMail* newsletter which reaches over 32,000 airport-area households and businesses.

The Commission began hosting a series of monthly roundtables to highlight issues related to Sea-Tac's master plan and providing national context as well. Topics in February and March included airport trends in technology, air cargo and international service; master plan work around the U.S.; working with airline customers and the traveling public.

Program staff presented to the Port Commission in January, Army Corps of Engineers staff, and the Seattle Chamber's Tomorrow @Sea-Tac coalition kick-off meeting.

Coordination meetings were held with Federal Aviation Administration representatives, and a comprehensive master plan update was provided to airlines operating at Sea-Tac. Nearly 20 activities were completed in this first quarter to reach the general public, federal, state and local elected officials, community groups and associations, and targeted stakeholder audiences.

Goals for Engagement

Throughout the development of the master plan, the Port is working closely to create wide public understanding of the planning work; to engage all stakeholder interests; and to focus on community and economic opportunity as part of the airport's redevelopment.

Outreach opportunities are designed to engage the general public; reach both local communities and regional audiences; brief government leaders at all levels; and connect with specialized audiences.

Staff maintains ongoing engagement with airport tenants and operators and provides regular briefings to the Commission in open public session.

2015 Outreach and Engagement Annual Report

Summary of Activity

Master Plan outreach in 2015 included recurring briefings to airport-area city representatives; presenting the first round of community open houses in Seattle, Bellevue and Des Moines; highlighting master plan material in *AirMail* newsletters, which reaches over 32,000 airport-area households and businesses; and initiating the Transportation Review Committee.

Work continued with briefings to regional elected officials at the Puget Sound Regional Council, King County Council, legislative committee members, and members and staff of the state's congressional delegation.

The second half of the year saw a particular emphasis on economic opportunity, with participation at local chamber business gatherings, several chamber presentations around the region, and Port-hosted business roundtables in the airport-area cities. Work concluded with outreach to environmental advocacy and transportation stakeholder groups, as well as preliminary briefings to the directors of the State Department of Ecology and of the Environmental Protection Agency, Region10 Administrator.

Throughout the year, program staff coordinated planning workshops, Steering Committee meetings, airline and Federal Aviation Administration engagement, and briefings to the Commission in public session. Over 90 activities were completed in 2015 to reach the general public, federal, state and local elected officials, community groups and associations, and targeted stakeholder audiences.
