## *Summary of Activity*

Master Plan outreach in 2Q2016 included presentations to the Burien City Council; the Federal Way City Council; chamber of commerce committees in both Seattle and Bellevue; the Sound Cities Association; and the North Beacon Hill Council.

Planning workshops were held with airport-area businesses concentrated along International Boulevard; airline customers; the cruise operations working group; ground transportation; the airport's Fire Department and the SAMP Transportation Review Committee.

The Commission continued hosting roundtables to highlight issues related to Sea-Tac's master plan and providing national context as well. Topics in April and June included working with community partners, and environmental sustainability during rapid growth.

Coordination meetings were held with Federal Aviation Administration representatives, as well as forums regarding social justice and community needs. Over 30 activities were completed in this quarter to reach the general public, federal, state and local elected officials, community groups and associations, and targeted stakeholder audiences.

The state Washington Public Ports Association recognized the Port's work in this area with its Community Outreach Award.

## *Goals for Engagement*



Throughout the development of the master plan, the Port is working closely to create wide public understanding of the planning work; to engage all stakeholder interests; and to focus on community and economic opportunity as part of the airport's redevelopment.

Outreach opportunities are designed to engage the general public; reach both local communities and regional audiences; brief government leaders at all levels; and connect with specialized audiences.

Staff maintains ongoing engagement with airport tenants and operators and provides regular briefings to the Commission in open public session.
