Since we first met on April 10th, 2018, I have been impressed with the Seattle Port Commissioners, and staff, on your "Centuries Vision" of obtaining new freight!

After meeting with the NW Seaport Alliance on January 15th, 2019, wherein I promoted the NW Seaport Alliance, you should have joint direct involvement working with the Eastern Washington County Commissioners, State Legislative Officials, and the Governor. I traveled to Olympia and received strong support for this promotion from legislators and Washington State AG Chairman Brian Blake.

On June 13, 2019 I made a request, and new offer, to US Selective Service Director Don Benton. Who, as you know, was the ex-Washington Senator and current contender for President Trump's White House Chief of Staff.

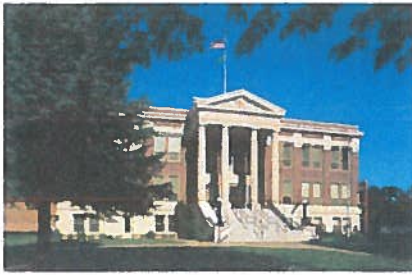


