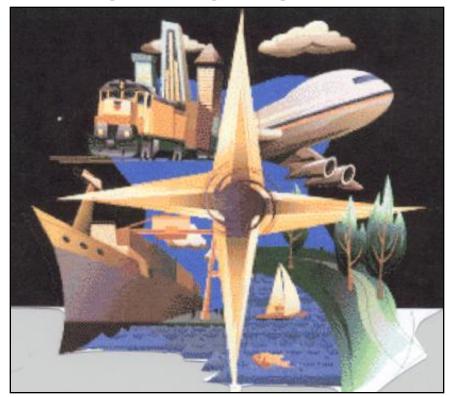

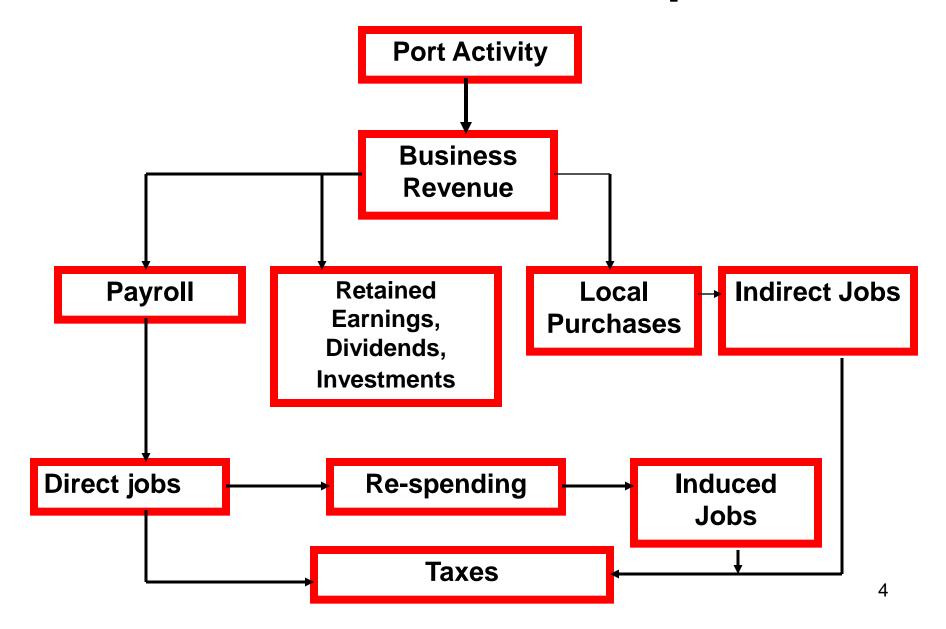
Purpose

- Measure the economic impact of the Port of Seattle:
 - Seattle Seaport:
 - Marine Cargo
 - Waterborne Passenger Activity
 - Fishermen's Terminal/Fishing Vessels Homeporting at POS Terminals
 - Marina Impacts
 - Non-Marine Cargo Real Estate Tenants
 - Sea-Tac International Airport

Purpose

- Measure the baseline impacts by operating unit
- Develop impact models that can be used for sensitivity analysis
- Compare the impacts with the 2003 impact study

Methodology

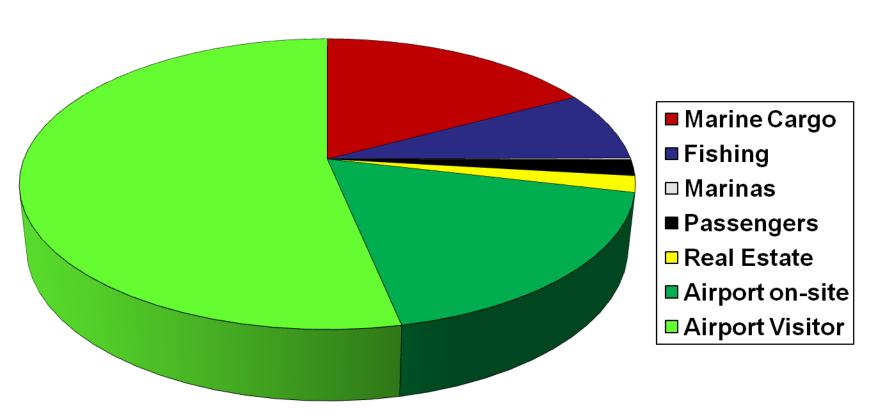
- Interviews with 929 Port tenants and service providers
- Formulation of direct impact models from interview data
- Development of Seattle induced and indirect job models
- In-terminal passenger survey (950 passengers)
- Cruise passenger survey (600 passengers and crew)

Total Port of Seattle Impacts:

- 193,986 total direct, induced and indirect jobs
- \$9.5 billion of personal income and consumption expenditures
- \$17.6 billion of business revenue
- \$1.4 billion of local purchases
- \$867.0 million of state/local taxes

IMPACT OF SMALL BUSINESS PROGRAM

- Port of Seattle spent \$53.6 million on services and construction contracts with local small businesses in 2007
 - 366 full-time equivalent direct, induced and indirect jobs
 - 90 jobs are with local minority and women owned businesses
 - \$16.9 million wages and salaries

Seaport Impacts



2007 Economic Impacts of Seaport Operations

- 56,255 total jobs
 - 21,695 direct
 - 26,716 induced
 - 7,845 indirect
- \$5.0 billion of wages and salaries
 - \$1.6 billion direct
 - \$3.1 billion induced and consumption
 - \$312.8 million indirect
- \$4.5 billion business revenue
- \$660.6 million local purchases
- \$457.5 million state and local taxes

Marine Cargo Methodology

- Interviews with tenants, terminal operators, service providers
- Develop operational models:
 - Surface transportation
 - Terminal operations
 - ILWU
 - Pilots/towing
- Develop induced model
 - Bureau of Labor Statistics, Consumer Expenditure Survey
 - Personal income multiplier from Bureau of Economic Analysis (BEA)

Marine Cargo Methodology

- Develop indirect model to convert expenditures into indirect jobs, income, and taxes – BEA RIMSII for Washington and King County
- Develop Sensitivity Model:
 - Cargo levels
 - Terminal productivity and operations
 - New projects terminal, warehouse, cranes, etc
 - Carrier and terminal analysis
 - Inland modal distribution
 - Comparative analysis of alternative uses
 - Ranking of projects

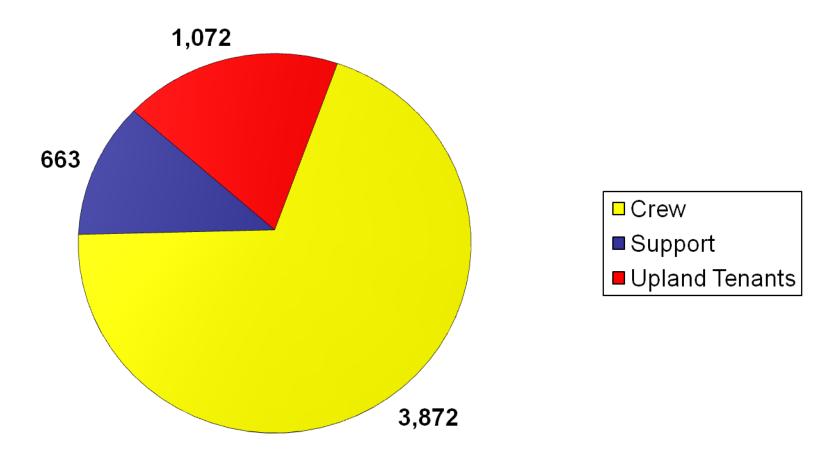
- Inventory of vessels moored at each facility, by type, provided by POS
 - Fishermen's Terminal
 - Terminal 91
 - Maritime Industrial Center
- Interviews with tenants (suppliers, boatyards, restaurants, retail, brokers, insurance, lawyers)
- Jobs to sales ratios and salaries developed from survey of suppliers, ship/boat yards, haul-out services, banking/insurance, equipment M&R
- Combined with total expenditures, by type, at each terminal

 - Shilshole
 - Bell Harbor
 - Fishermen's Terminal
 - Harbor Island
- Interviews with tenants (yacht clubs, schools, restaurants, retail, etc.)
- Development of typical annual expenditures by type and for transient
- Development of jobs to sales ratios, revenue and income for suppliers of services from surveys

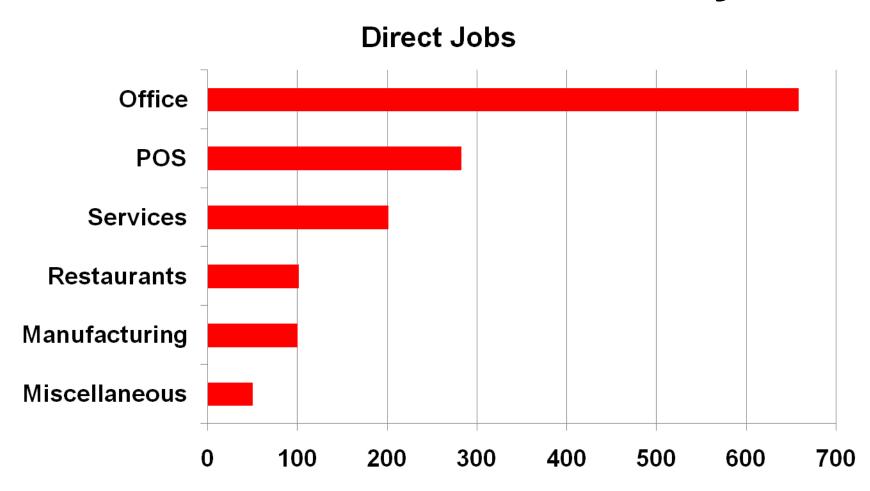
Real Estate

Impacts of Sea-Tac International Airport



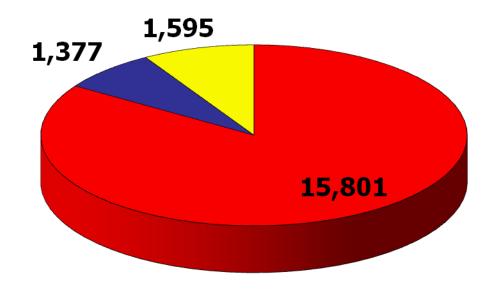

Distribution of Direct Jobs by Type of Activity, 2007

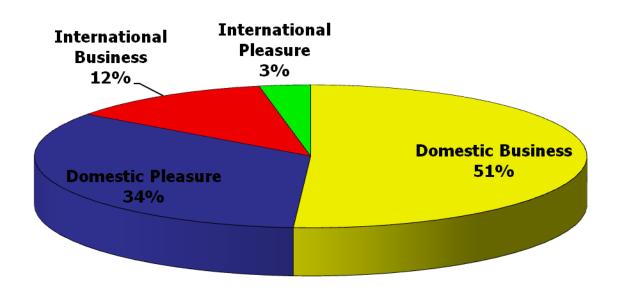

7.6 Million Visitors Used Sea-Tac International Airport in 2007



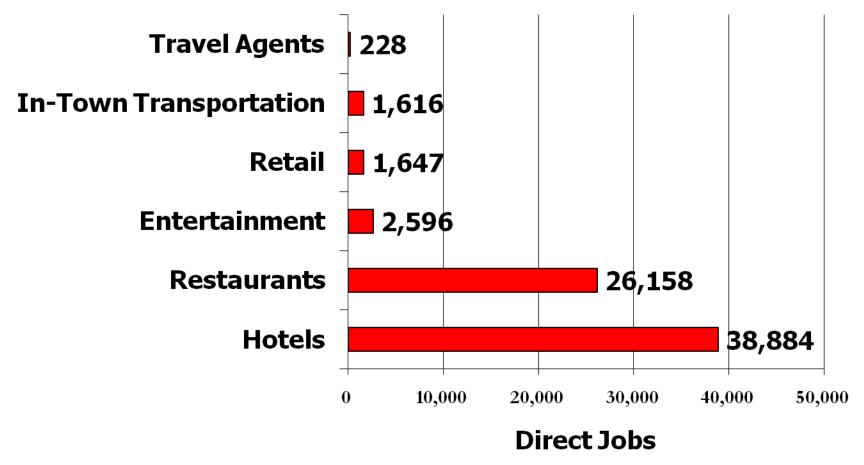


Distribution of Local Visitors' Purchases - \$5.5 Billion

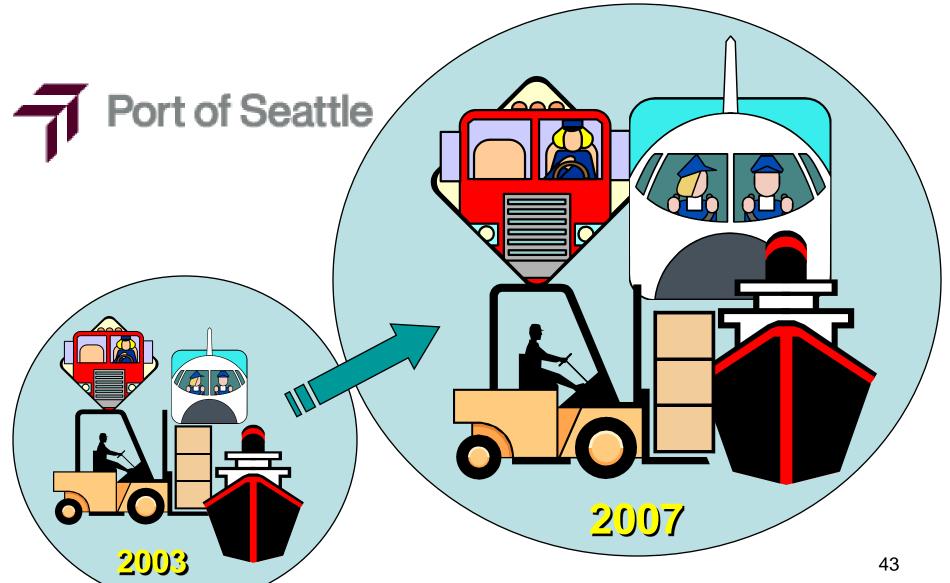

Changes In Impacts Since 2003



Structural Changes

- Personal Earnings Multiplier
 - Specific waterborne transportation sector income multiplier now estimated by BEA
 - 1.98 in 2003 to 4.095 in 2007 (higher earnings)
 - Results in significant growth in induced jobs and respending impact
- Jobs to sales ratios have fallen, particularly in ship and boat yards
- Overall jobs to sales ratios have fallen for indirect jobs

- Tonnage Changes:
 - Growth in containerized cargo and grain
- Operational Changes
 - Increased share of intermodal cargo
 - 65% in 2003
 - 75% in 2007
 - Inclusion of barge based crew for Alaskan break bulk
 - Terminal productivity remained nearly the same as did charges

Changes in Fishing Impacts

- Decline in number of fishing fleet at Fishermen's Terminal:
 - 370 ships in 2003
 - 250 ships in 2007
- Growth in factory trawlers and processors at T-91:
 - 21 vessels in 2003
 - 58 vessels in 2007
 - Increase in crew and average annual salary
- Decline in boatyard employment per dollar of expenditures
- Increase in income multiplier since 2003 induced jobs and re-spending impact
