

## **RESOLUTION NO. 3644**

**A RESOLUTION** of the Port Commission of the Port of Seattle, declaring certain personal property surplus and no longer needed for port district purposes and authorizing its sale by public auction.

**WHEREAS**, the voters of King County, pursuant to the provisions of enabling legislation adopted by the legislature of the State of Washington, Chapter 92, Laws of 1911, RCW 53.040.010, authorized and approved at a special election held in King County on the 5<sup>th</sup> day of September 1911, the formation of Port District co-extensive with King County to be known as the Port of Seattle; and

**WHEREAS**, the Port of Seattle was thereupon established as a Port District and has since been and now is a duly authorized and acting Port District of the State of Washington; and

**WHEREAS**, the Port of Seattle ("Port") owns certain personal property described below; and

**WHEREAS**, said property is no longer needed for its intended purpose, or other purposes of the Port; and

**WHEREAS**, the Port desires to surplus said personal property and dispose of it pursuant to RCW 53.08.090,

**NOW, THEREFORE, BE IT RESOLVED**, by the Port Commission of the Port of Seattle, as follows:

**Section 1:** The following personal property is no longer needed for Port purposes and it is in the best interest of the Port that said property be declared surplus and sold or disposed of:

Miscellaneous surplus furniture, kitchen equipment and audio visual equipment.	\$ 2,000.00
<b>Seaport Items</b>	<b>Estimated Resale Value</b>
One pick-up, miscellaneous office furniture, miscellaneous shop tools and shop supplies	\$1,500.00
<b>Aviation Items</b>	<b>Estimated Resale Value</b>
Three forklifts, sweeper, vacuum, scooter, Snowblast broom, 28 sedan automobiles; 2 sports utility vehicles, 2 pick-ups, 4 buses, 2 vans and 1 trailer; miscellaneous office equipment, furniture, fixtures; miscellaneous shop tools and supplies	\$95,000.00
Total Estimated Resale Value	\$98,500.00

**Section 2:** The Chief Executive Officer is authorized to take all necessary steps to arrange for the sale of said property by public auction and to execute all documents necessary to accomplish its disposal in accordance with State law.
