The Port of Seattle Commission met in a special meeting at 10:00 a.m., Tuesday, June 22, 2010 at Redmond City Hall, 15670 NE 85th St., Redmond, WA. 98073. Commissioners Albro, Bryant, Creighton*, Holland and Tarleton were present.

The regular meeting was called to order at 10:07 a.m. by Bill Bryant, Chair and President.

Commissioner Bryant acknowledged Redmond City officials present at the meeting, and also noted that immediately following the meeting, there would be a press event arranged by the City of Redmond where CEO Yoshitani would sign the Purchase and Sale Agreement which was the topic of today's meeting.

a. (00:03:27) Resolution No. <u>3638</u>, as amended; Second Reading and Final Passage. Declaring certain real property located in the City of Redmond and unincorporated King County (a portion of the Redmond Spur segment of the Woodinville Subdivision) surplus and no longer needed for Port purposes, and authorizing the Chief Executive Officer to execute all documents necessary for its transfer to the City of Redmond.

Prior to the presentation, CEO Yoshitani commented on his delight in achieving what is an important milestone, both for the City of Redmond and for the Port of Seattle. He thanked Redmond Mayor Marchione and members of the Redmond City Council for their leadership. He also recognized members of Port staff for their hard work involved with completing the necessary transactions. Mr. Yoshitani also thanked the Port Commissioners for their leadership, commitment and encouragement throughout the project.

Mr. McWilliams noted a technical correction to the description in the Resolution, a difference between the version presented at First Reading and that being presented today, which recognizes that one parcel within this transaction lies within unincorporated King County.

Mr. McWilliams reviewed the location of the spur; stated that the purchase price is \$10M and noted that closing costs are anticipated to be less than \$10,000.

Commissioner Bryant then recessed the special meeting to an open Public Hearing.

*Commissioner Creighton was present at the meeting from this point forward.

Public comment was received from the following individuals:

- Robert Scheuerman, Eastside Rail Now. Mr. Scheuerman congratulated the Port of Seattle and the City of Redmond in reaching this final agreement, and noted that a railroad right-of-way is a rare and valuable asset.
- Rosemary lves, former mayor of Redmond. Ms. lves spoke in support of the Resolution, stating that it was a job well done.
- Richard Cole, President, Redmond City Council. Mr. Cole welcomed the Commission to the City of Redmond, spoke briefly about the history of the railroad in the area and about partners who will be using the railroad in the future.
