## THIRD AMENDMENT TO LEASE BETWEEN RT OF SEATTLE AND SEAVIEW BOATYARD WEST. II

THIS THIRD AMENDMENT TO LEASE made as of \_\_\_\_\_\_, 2011, by and between the PORT OF SEATTLE, a Washington municipal corporation, hereinafter called "the Port," and SEAVIEW BOATYARD WEST, INC., a Washington corporation, hereinafter called "Lessee,"

## WITNESSETH:

WHEREAS, the parties entered into a Term Lease agreement dated July 23, 1996, hereinafter called the "Basic Lease," of approximately 62,844 square feet of yard space at Shilshole Bay Marina, Seattle, Washington, at a monthly rental of \$9,860.64; and

WHEREAS, the parties now wish to amend the Basic Lease to increase the leased area by one thousand five hundred forty one (1,541) square feet, effective July 1, 2011, with a corresponding increase in rental;

NOW THEREFORE, in consideration of their mutual promises, the parties hereby agree as follows:

- 1. The leased area is increased from 62,844 square feet to 64,385 square feet, effective July 1, 2011.
- 2. The total monthly rental payable by Lessee is increased from \$9,860.64 to \$10,102.44, effective July 1, 2011, based on the following calculations:
