The estimated cost for these services is \$350,000 over four years starting in mid-2012 and ending in mid-2016. (memo enclosed)

Authorization for the Chief Executive Officer to execute up to two professional services indefinite delivery, indefinite quantity contracts for dock and diving support services for a not-to-exceed amount of \$2,000,000 (\$1,000,000 each) with a three-year ordering period upon execution. No funding is associated with this authorization. (memo enclosed)
