






Working towards Guaranteed Maximum Price (GMP)

Second Contract Period

- GMP Development Period:
 - Advance design to 60% level (or beyond)
 - Preliminary construction, including the purchase of long lead-time items (e.g., steel, escalators and elevators)
 - Negotiate Guaranteed Maximum Price (GMP) for the work (4Q16)


