PRESIDENT ABRAHAM LINCOLN HAD ISSUED THE EMANCIPATION [00:08:23] PROCLAMATION TWO AND A HALF YEARS EARLIER, BUT ENSLAVED AFRICAN AMERICANS IN TEXAS [00:08:30] A STATE THAT WAS THEN A RURAL FRONTIER WOULDN'T LEARN OF THE NEWS UNTIL THE ARRIVAL OF THE [00:08:36] UNION ARMY. [00:08:38] JUNETEENTH WAS PIVOTAL THROUGHOUT THE FORMER CONFEDERATE STATES IN ENDING [00:08:44] SLAVERY IN THE UNITED STATES BECAUSE THESE WERE STATES WHERE THE LARGER POPULATIONS OF [00:08:49] AFRICAN AMERICANS HAVE BEEN ENSLAVED.
