## ADOPTION OF RESOLUTION TO SURPLUS TRACT B IN THE DES MOINES CREEK BUSINESS PARK



## **Executive Summary**

- **Commission approved** the 2012 Development Agreement and 2016 Ground Lease for the construction of Des Moines Creek Business Park.
- Permits (Clean Water Act) required the construction of two stormwater facilities (Tract A and Tract B stormwater retention ponds) to be built concurrent with the adjacent development phase, for conveyance to the City of Des Moines upon completion and the City's acceptance.
- In a prior action (2017) **Commission approved** the surplus of Tract A and conveyance to the City of Des Moines.
- Tract B stormwater improvements are complete and have been accepted by the City of Des Moines. This action requests approval of the surplus and conveyance of Tract B.
- Commission heard the First Reading and Public Notice of Resolution 3799 to surplus Tract B on January 25, 2022.

## Prior Approval Authorizing Tract B Surplus

• 2012 Development Agreement between Port and City of Des Moines SECTION 12. DRAINAGE REQUIREMENTS AND INFRASTRUCTURE

12.1 General. The Port shall provide stormwater facilities to address surface water runoff created as the result of development of the Property. All stormwater facilities shall be located in separate public tracts.
