The Port of Seattle Commission met in a special meeting Tuesday, June 13, 2023. - current U.S. SAF consumption and production forecast;
- technology and its influence on price;
- locating facilities and producing SAF;
- benefits of SAF:
- lifecycle greenhouse gas emissions reductions with SAF;
- air pollutant reductions with SAF;

- SAF expansion enablers;
- the Port's role in SAF;

- SAF federal policy successes and opportunities;
- Progress in the arena of sustainable aviation fuel development since 2018; and

Members of the Commission and staff discussed:

- the cost of different SAF sources:
- co-locating source and production facilities to cut down on transport costs;
- seeing more efficient airline fleets;
- power-to-liquid sources and creating storable forms of energy;
- if there are other producers looking to use Municipal Solid Waste as a source;
- percentage of SAF production anticipated in the future;
- contrail impacts and preventing contrails;
- if losing commercial viability to cheaper fueled airports is a concern it was noted that major airports around Seattle are also exploring SAF use;
- production of renewable diesel and if it can help reduce the net cost of SAF production;
- tracking carbon intensity scores;
- retooling refineries for production;
- the need for longer-term certainty for investors;
- evaluating the impacts of ultrafine particles; and
- state and federal legislation supporting SAF.
