Delegation of Authority (DORA) One-Year Update

DORA One-Year Background

Resolution No. 3810 adopted in January 2023 update delegation authority to the Executive Director to \$2M.

Section 3 of Resolution No. 3810 states "[t]he Executive Director shall provide to the Commission a review of the processes and procedures for implementing the new Delegation of Responsibility and Authority Policy Directive at one year after the implement of the new directive."

Process developed with input from Commission and departments and launched in May 2023. Presentation today is review of data from May 2023 to May 2024.

97 requests submitted and approved. 85 of the 97 requests were between \$1.5M and \$1.9M range.

26 items ranging from \$2M to \$4.9M were included on consent during the same time frame.
